Port State Control Inspection Results & Data

The purpose of this notice is to advise shipowners, operators, managers and Masters of Isle of Man registered ships of information in respect of Port State Control activities

The Ship Registry wishes to advise those concerned of the following information and collected data on port state control inspections during the first 3/4 of 2016.

The total number of inspections recorded to date as of 30th September 2016 is 629 which is a drop of approximately 11% on the 2015 figure in the same period. There have been a total of 6 detentions in the 9 month reporting period which represents 1% of all inspections

By age of vessels; 1 ship under 5 years, 2 ships of between 5 and 10 years, 1 ship of between 10 and 15 years and 2 ships of 15 to 20 years have been detained.

By tonnage (GRT); 1 ship of between 3000 to 10,000, 3 ships of between 10,000 to 50,000 and 2 ships of between 50,000 to 100,000 GRT were detained.


By type of vessel; bulk carriers 4 detentions, oil tankers 1 detention and gas tankers 1 detention.

By Country of detention; 5 ships in Tokyo MoU Region, 4 in China, 1 in Australia, then in the in Black Sea MoU Region, 1 ship in Russian Federation.
