### PERSONS QUALIFIED TO OWN A MANX SHIP

The following persons and organisations are qualified to own a Manx ship under Section 2 of the Merchant Shipping Registration Act 1991:

#### **Individuals.**

- British Citizens;
- British Overseas Territory Citizens;
- British Overseas Citizens;
- British Subjects;
- British Nationals (Overseas); or
- A citizen of any of the countries listed in Schedule 1.

#### **Bodies Corporate.**

Bodies Corporate incorporated in any of the following countries and having their principal place of business in any of the following countries:

- The Isle of Man;
- The United Kingdom;
- The Channel Islands; or
- Any of the countries listed in Schedule 1.

#### **Limited Partnerships.**

1. Limited partnerships must:

a) have their principal place of business in:

- The Isle of Man;
- The United Kingdom;
- The Channel Islands; or
- Any of the countries listed in Schedule 1, **AND**



- b) be registered in any of the countries listed in paragraph 2; **AND**
- c) have a general partner which is:
- i) an individual resident in any of the countries listed in paragraph 2; **OR**
  - ii) a body corporate incorporated and which has its principal place of business in any of the countries listed in paragraph 2.

  - Belgium;
  - Bermuda;
  - The Cayman Islands;
  - Denmark;
  - Germany;
  - Malta;
  - Norway;
  - Sweden;
  - The Netherlands; or
  - The United Kingdom.
