Port State Control Inspection Results & Data from 2017

The purpose of this notice is to advise shipowners, operators, managers and Masters of Isle of Man registered ships of information in respect of Port State Control activities

The Ship Registry wishes to advise those concerned of the following information and collected data on port state control inspections during 2017.

The total number of inspections recorded to date as of 1^{st} January and the 31^{st} December 2017 is 891 which is an increase of approximately 47 inspections or 5.4% on 2016. There have been a total of 10 detentions in the reporting period which represents a 1.1% detention ratio of all inspections during 2017, while 2016 equalled a 0.8 % detention ratio.

By age of merchant vessels, 5 ships were detained between 5 and 10 years of age, 1 ship was detained of between 10 and 15 years of age and 2 ships were detained of between 15 to 20 years of age, and 2 x commercial yachts

Detentions by tonnage (GT); 1 ship under 1600 GT, 3 ships of between 3,000 and 10,000 GT and 2 ships of between 10,000 and 50,000 GT, 1 ship of between 50,000 and 100,000 GT and 1 ship of over 100,000 GT.


By type of vessel; bulk carriers 2 detentions, gas tankers 3 detentions, cargo ship 3 ships, and two commercial yachts.

By MoU Region and country of inspection; 5 ships in the Tokyo MoU Region, 4 in China, 1 in Australia: then in Paris MoU Region, 1 ship in Germany and 2 x commercial yachts in Italy; in Black Sea MoU Region, 1 ship in Ukraine, and the in USCG 1 ship in USA.
