MERCHANT SHIPPING (REGISTRATION) ACT 1984

AN ACT to make fresh provision in relation to the registration of British ships in the Island; and to provide for the appointment of marine surveyors.

1 [Repealed]¹

2 Appointment of Marine Surveyors

[Berm 1979 No 16/6]

- (1) There shall be appointed a Marine Surveyor.²
- (2) The functions of the Marine Surveyor shall be to secure the safety of ships, the safety, health and welfare of seamen and the prevention of pollution from ships.
- (3) There may be appointed one or more assistant marine surveyors, who shall exercise their functions in accordance with the directions of the Marine Surveyor.³
- (4) For the purpose of ensuring that any statutory provision relating to the safety of ships, the safety, health and welfare of seamen and the prevention of pollution from ships has been complied with, a surveyor appointed under this section may at all reasonable times go on board a ship and inspect the ship and its equipment or any part thereof, any articles on board, and any document carried in the ship in pursuance of any statutory provision.
- (4A) In making an inspection under subsection (4), a surveyor shall have all the powers conferred on an inspector by section 3 of the *Merchant Shipping Act 1985*.⁴

3 Interpretation

- (1) In this Act “**the Department**” means the Department for Enterprise.⁶

4 Short title and commencement

- (1) This Act may be cited as the Merchant Shipping (Registration) Act 1984.
- (2) This Act shall come into operation on such day as the Board may by order appoint and different days may be appointed for different provisions.⁸
